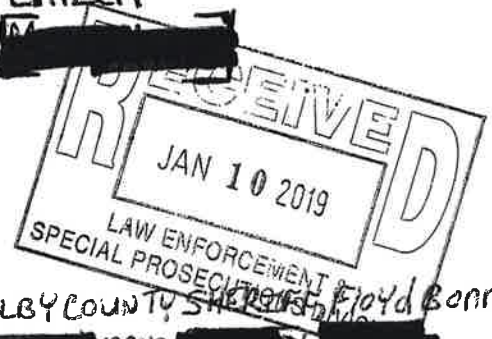

What relevant evidences does the Prosecutor(s) have to connect me to the allegations in such case
I sent you a letter by mail ON Dec. 12, 2018, requesting a
meeting (visit) with you to talk about my ^{reserved} rights and power
being exercised or deprived BY your representation.
You have failed to meet with me per my request.

I have been unlawfully confined or restrained (Kidnapped)
against my consent and rights reserved, and held hostage in 23/4 since 12/2/18
within the [Redacted] County Jail since [Redacted], ON defective Warrant
Indictment Numbers [Redacted]; ETC., that lacked
sufficient evidences, to secure any conviction against
me, from the beginning. It is obvious that such Indictments
and Warrants ^{and placement in 23/4 housing for phone restriction order} were issued against me by the ministerial agents
of the [Redacted] COUNTY CRIMINAL DIV. 5 COURT in excess of
jurisdiction, [Redacted] from the beginning, Causing them to be VOID AB INITIO,
Which is ground for Dismissal - [Redacted] for lack of Jurisdiction (Personal).

Also, It is obvious that these are Vexatious^{orders,} ^{maliciously,} [^]Indictments and Warrants instituted[^] by the ministerial Agents of this Court, against me, without sufficient evidence(s) or lawful ground(s), to cause^{me} harassment, trouble, and financial Hard ship, from the beginning, because I declared my True National!

Any ONE who has studied law, should[^] know that these are frivolous and vexatious Indictments and Warrants, and ord if that Lawyer provided effective Assistant, as my representative, from the beginning.
